Answering a question regarding leaking/leaching pipes, Water Plant operator, Pentasuglia, stated that the Town tests all pipes within the Town on a rotating basis. These tests are within acceptable levels now as they have been in the past. Beckman was very complimentary regarding the Water Plant and the Town.
