Initial Tap Fee	\$250.00	Minimum plus additional costs if line extensions, etc... are required
Water Deposit	\$ 50.00	Due when agreement is signed, Refundable after 12 consecutive on time payments
Sewer Deposit	\$ 50.00	Renters Deposit will <u>only</u> be returned after service is disconnected.
Meter Test	\$ 30.00	Only if meter tests good
Meter Rereading	\$ 10.00	Only if reading was correct
Reconnection Fee	\$125.00	Due if meter has been removed for nonpayment
Disconnect Fee	\$ 40.00	Due if water service is turned off for nonpayment
Administrative Fee	\$ 20.00	Due if payment is collected at customer's door to prevent water termination
Bill Reprint Fee	\$ 1.00	Due if customer does not provide bar-coded section of bill with payment

Note: If water lines are not available, the cost of connection to the system will be the minimum tap fee plus additional costs for line extension. A quote can be obtained thru the business office.

ELEVATION RESTRICTIONS: The Athens water system operates over a wide elevation range. The maximum elevation at which we can offer service standard service is given below.

In the event that the applicants' service location is above elevation, this application constitutes a waiver of the minimum pressure requirements set forth by the PSC.

HIGH PRESSURE WARNING: As a result of large elevation differences between our tank elevations and many of our customer’s service locations, much of our system operates at high pressure. Customers can obtain the theoretical static pressure at their service location by calling the Athens town hall and providing your service elevation. **PRESSURE SPIKES RESULTING FROM MAINTENANCE WORK, FIRE DEPARTMENT ACTIVITY, AND OTHER CAUSES OCCUR OCCASIONALLY THROUGHOUT THE SYSTEM.** Although the Town of Athens has installed some pressure regulating equipment in various locations throughout our system, the combination of static pressure and pressure spikes as described above can result in pressure capable of damaging plumbing and appliances. **THE TOWN OF ATHENS CANNOT PREVENT OR BE HELD ACCOUNTABLE FOR THE HIGH PRESSURES WHICH EXIST IN OUR SYSTEM.** Leaks resulting from damage from high pressure can result in significant losses of water and or damage to homes. All water customers of the Town of Athens are strongly advised to have a cutoff, pressure reducing and a pressure relief valve installed in their service line by a licensed plumbing contractor. This equipment if properly installed and maintained can prevent damage from high pressure in most instances. The Town reserves the right to deny service to customers declining to install this equipment.
